Youth Thumb Region Poster, Essay & Oratorical Contest

"Marijuana & Alcohol – Impact On Health"

PURPOSE: The 1st "Youth Thumb Region Poster, Essay & Oratorical Contest" seeks to promote the ability of Thumb Region students (between the 7th and 12th grades) to either provide a speech, write an essay or graphically represent key issues related to health and wellness. Contestants will choose one (1) area [oratorical video, essay or poster] to craft a submission that directly and persuasively addresses the contest topic. The contest is sponsored by Thumb Region Seventh-day Adventist Churches.

TOPIC: "What negative health effects does Marijuana and Alcohol have on the brain and body?"

ELIGIBILITY REQUIREMENTS:

- 1. Contestants must be in grades 7 12. Students having graduated high school before 9/1/2021 are not eligible.
- 2. Contestants must have their legal residence in either Tuscola, Huron or Sanilac County, MI.
- 3. Contestants may be in a public, parochial, private or home-school setting.

DEADLINE & SUBMISSION REQUIREMENTS: Submissions must be received via email before 12:00 midnight **December 31** (EST) to the following email address: <u>thumbregioncontest@gmail.com</u>. Submissions received outside of this timeframe will be disqualified. All items in your category of choice must be submitted via email.

* Essays must be emailed in **PDF** format \ ^ Videos must be uploaded to **Youtube.com**, with a **link** to the video sent to the contest email \ ~ Posters must be saved as a **high resolution JPG** file (300 pixels per inch) or as a **PDF** file, and then emailed.

AWARDS: In total, \$10,000 in prize money will be awarded across the three contest categories.



JUDGING: Award decisions in all three contest categories will be determined by submission: ¹originality and clarity of thought; ²evidence of knowledge of the topic; ³persuasiveness of argument or depiction; ⁴refinement of expression (i.e. use of appropriate words, rhetoric or graphic artistry); and ⁵preciseness of execution (i.e. correct grammar or effectiveness of visual artistic depictions). Contest winners will be announced in late January or early February, 2022.

CONTEST RULES:

Contestants may only submit one (1) entry. Therefore, contestants must choose the one contest category (oratorical, essay or poster) in which they will make a submission.

ORATORICAL SPECIFIC RULES:

- 1. Contestants are to videotape an original speech that directly addresses the contest topic.
- The speech is to be 2 3 minutes in length. A contestant will be disqualified if the speech is timed to be less than 2 minutes or more than 3 minutes in length. [Contestants are urged to use as much of the 3 minute allowable time as needed to make a persuasive and substantive argument].
- 3. Appropriate gestures are allowed. Props are not allowed.
- 4. The style should be appropriate to the message of the speech. A monotone presentation is not recommended.
- 5. The contestant should use up-to-date evidence-based factual information.
- 6. Although quotes to support a position or statement are appropriate, they may not dominate the speech, and should be appropriately citied.
- 7. The speech should appeal to a broad audience [i.e children as well as adults].

ESSAY SPECIFIC RULES:

- 1. Contestants are to write an original speech that directly addresses the contest topic.
- 2. The essay is to be limited to 1,000 words. A contestant will be disqualified if the essay exceeds this amount.
- 3. Citations should be placed in footnotes, endnotes or a bibliography, and are excluded from the word count.
- 4. The contestant should use up-to-date evidence-based factual information.
- 5. Although quotes to support a position or statement are appropriate, they may not dominate the essay, and should be appropriately citied.
- 6. The essay should appeal to a broad audience [i.e children as well as adults].

POSTER SPECIFIC RULES:

- 1. Contestants are to create an original infographic or poster, which may be computer generated, graphically designed or hand drawn.
- 2. The infographic or poster must be 8.5"x11" in size.
- 3. Citations for all data and quotes should be placed as endnotes.
- 4. Bold colors, clear artwork and large easy-to-read messages should be considered when preparing your poster.
- 5. The contestant's artistry or graphic design should be informed by evidence-based factual information.
- 6. The poster should appeal to a broad audience [i.e children as well as adults]..
